What is Patient Safety?²

Patient Safety is the prevention of errors and adverse effects to patients associated with healthcare.²

What is a Patient Safety event?

The working definition of a patient safety event is “an event which resulted in, or could have resulted in, unintended harm to a patient by an act of commission or omission, not due to the underlying medical condition of the patient.”³

What is a culture of safety?

“An integrated pattern of individual and organisational behaviour, based upon shared beliefs and values that continuously seeks to minimise patient harm, which may result from the processes of care delivery.”⁴



Our four pillars of Patient Safety



Healthcare-associated infections are a heavy burden

Among Patient Safety events are HAIs. They can occur at any stage of the patient journey in hospital. They are responsible for increased mortality and increased healthcare costs.
